## **GGC REPORTS**

### **FINANCE COMMITTEE REPORT**

The Finance Committee duties are found in the Constitution & Bylaws on page DELMAR-B-GGC Article IV Committees 3 (b). Those duties include but are not limited to:

1. Audit the books of the Grand Secretary and Grand Treasurer.
2. Approve or disapprove expenditures exceeding the budget adopted at the Annual Meeting.
3. Select the bank to be used by the Grand Guardian Council taking into consideration the location of same with the Grand Treasurer.
4. Assist the Vice Grand Guardian and/or Vice Associate Grand Guardian in preparation of the budget.

The Committee Chair conferred with the Vice Grand Guardian on her plans for the 2020-2021 budget. Once the budget was completed, the Chairman sent the budget to the Committee for approval. The Committee approved budget.

We firmly believe that all committees should be aware of the spending and income plans for their committee and should work within these numbers. Proposed budgets should be received 45 days prior to the project with the final report within 15 days of the completion of the project. It appears that many of our committee chairman do not know how to submit a budget or write their final report. Examples of these forms are found in the Handbook. All expenditures should be submitted in a timely fashion to ensure proper reporting. I can report that very few chairmen submitted a budget and even fewer submitted the final report.

The Finance committee has tried to work together for the good of this Grand Guardian Council – keenly watching the financial condition of our Council always.

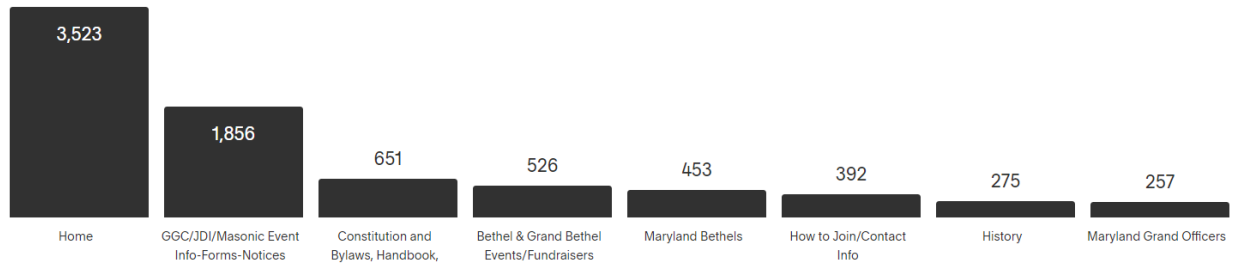

So, when things didn't work out how I expected them to I didn't give up; I just made the necessary adjustments as we continued to find the right path for the new DelMar Jurisdiction. I would like to thank the members of the GGC who voted for me to be the first Grand Guardian of DelMar, and to those who have also shown their continued positive support throughout this everchanging year of firsts. At times it has been difficult for some of our members to let go of the past and embrace the necessary changes that the merger brought to us, but the DelMar Jurisdiction has continued to move forward in many positive ways, of which I am very proud. This merger between Delaware and Maryland has allowed our Daughters to grow, shine, and make many new Jobie friends across our Jurisdiction, and to also have many new experiences. Although this year has sometimes been a difficult journey, together we have created the dynamic Jurisdiction of DelMar.

I started this year filled with hope and ambition, ready to complete the necessary work needed to merge Delaware and Maryland into our new DelMar Jurisdiction. In June, we had to create the DelMar Manual of Rules and Regulations, Book of Narratives, Handbook, and Book of Ceremonies in a very limited timespan. This was a big undertaking, but with a small group of dedicated adults, we were successful. For the most part the feedback from the GGC members was positive, with only minor housekeeping changes needed. With the merging of ceremonies from both Jurisdictions, we all had new things to learn this year, and so we chose to host training sessions for Bethel Council members and Daughters. These training sessions, and our 2 CAV classes, were all very well attended, and I would like to thank everyone who shared their expertise.

It has truly been a very busy year! Between May 11, 2019 - March 14, 2020, when we were closed for the rest of the term due to the Coronavirus, I traveled over 13,000 miles; often accompanied by the Daughters of DelMar, which made for some very memorable trips and a lot of ice cream & Wawa stops. Besides regular Bethel meetings, initiations, and Bethel activities, I was also able to attend 23 Bethel & Grand Bethel installations, 8 Grand Visitations, Pennsylvania & Supreme Sessions, Installation of the Delaware OES, Delaware's Youth Committee meetings, Delaware's Youth Festive Board, Maryland's Tri- Youth Worship Service, DeMolay's Conclave, the York Rite Installation, the Scottish Rite Awards Day, Delaware's Semi-Annual and the installations of both the Delaware & Maryland Grand Masters. Attending these events with the appendant bodies in both states allowed us to bring greetings from DelMar JDI and help them to better understand how the merger benefited all of our Daughters.

Due to the Coronavirus and subsequent quarantine, we were challenged to find new ways for our Bethels and Councils to continue to meet after all activities were suspended by Supreme. The last few months of this term became a true labyrinth to navigate with the ever-changing rules from many of our different governing entities. I am so very proud of how creative our Bethels became so they could continue to meet virtually at least one time a month.

While we did gain 23 new members overall this GGC term, Supreme did have us close Bethel #4 in Georgetown due to lack of membership. We were able to hold off on this action until after our DelMar pageant in December, which allowed the last Miss Delaware to finish her term in her home Bethel.

Sadly, the deepest valleys to date involved working directly with the adult members of our GGC and the continued politics & obvious cliques. I had hoped that this would be the year that our GGC adults would finally present as one cohesive group, but sadly this did not happen. Our Daughters often questioned the obvious split which was so apparent in our Grand Line and with many of our GGC members. I think we need to be more aware of how our Daughters and others perceive our actions and comments, both at GGC and Bethel events.

My biggest ongoing concern throughout the course of this year was that our adults did not fully understand their responsibilities within the GGC. Many of our adults seem to accept positions without making themselves fully aware of what is involved when accepting the responsibility of that job. Going forward, I think it would be helpful if the previous committee chairperson was able to meet with the new committee chairperson after our annual meeting. This would allow them to discuss what the new chairman will need to do to make their committee continue to run smoothly. It would also allow them to pass on any necessary materials to the new chairperson if they would not be needed at the following week's Grand Session.

I think it is also important for the members of the Bethel and Grand Guardian Councils to become familiar with all their specific responsibilities, beyond what is listed on their certificates. Often this year our Ways & Means table was run by our Daughters rather than the Grand Officers who should, according to the DelMar Rules and Regulations, have been in charge. Apparently, some felt it was appropriate to refuse to help, even though the money raised funded many of our ongoing GGC activities. While I truly appreciate our Daughters choosing to step-up, it was not their responsibility and I am very disappointed that they had to witness adults in our organization acting in this manner.

As a Majority Member of Job's Daughters International, I have actively worked with Maryland/DelMar JDI and Bethel #35 since 2007. I found it interesting this past December when my husband was informed that I would not be "allowed" to be on any Bethel Councils or GGC/Bethel Committees. While this was probably intended to be hurtful, it just clearly demonstrates the vindictive pettiness of specific members of our Grand Line. In the future, statements like this should be made directly to the person that is being spoken of, rather than to their family members or other members of DelMar Job's Daughters. While I may not be welcome this year to work with the DelMar GGC, or to attend any of the GGC events, I do know that I will always be welcome at Bethel #35. I also know that I do not need to be on their Council to continue to support the members of this Bethel, or any other Bethel that asks for my help.

On a more positive note, we did have several beautiful views from the mountain top this year. Our Misses represented us very well at the Supreme Session in Kansas City, and several of our Daughters competed successfully in both Ritual and Arts & Crafts. Our Leadership Weekend was well attended by both Daughters and Council members, and our first ever Virtual Walk Challenge series raised over \$1,000 for HIKE and the Gary Sinise Foundation. For the first time we were

able to honor five of our Majority members with the Lily of the Valley award and two of our Majority members with the Degree of Royal Purple. It should be noted that this was the first time anyone from Maryland was eligible to receive either of these awards. We were able to award scholarships to our Daughters and Majority Members, and Mom Mary Lou Walter, PGG received the PGM Naquin award for Masonic Youth Service. We also continue to increase our membership through initiations, and several of our Daughters created many memorable promotional opportunities.

Finally, we need to remember that we are blessed to work with over 100 amazing young ladies that make up the 11 Bethels in the DelMar Jurisdiction, and these are the people we should be representing through our actions. Our Daughters are compassionate, talented, inspirational leaders, and I am so proud to have had this opportunity to work with them as the 1<sup>st</sup> Grand Guardian of DelMar!

We had a slight hiccup with the name change with the state of Maryland, but we worked through it and finally got it changed. The changing of our name with vendors I use, is an ongoing process, as I am updating as I use them. All in all, everything has worked out in the end and I am a much stronger person due to the challenges I faced. I truly understand why Supreme asked me to stay on, as this would not have been an easy job for a first time Grand Secretary.

In December, I sent the Bethels the necessary paperwork for completing the Annual Report. Even with having some first time Guardian Secretaries, all reports were received in the GGC office by the deadline and I was able to have the Annual Report filed with the Supreme Office well before their deadline. Again, the membership listing was correct from Supreme, so that always makes life easier.

Most Committee Chairs failed to submit their financial reports in a timely manner. When you submit your financial reports please indicate if there are any GGC checks that need to be written. All monies from the committees were turned in quickly and any checks needed to be written were also sent out in a timely manner.

The majority of our members elected to have the mailing sent electronically. I have received many positive comments in regards to this practice. I am still using the same vendor for the GGC and Bethel electronic mailings and it has worked extremely well. I have a small amount of people to which I still send paper mailings. Most have requested just the important information (directories, dues, Grand Session info, etc.), as they are up there in age and are not traveling. Information from the mailings is also being posted to the GGC Website and listserv. It is still important to remember that not all members of the GGC or Bethel Councils are part of the listserv, so please make sure you send a copy to the Grand Secretary to include in the mailing and to be posted to the website. I also updated the website to include a communications page. Any communication can be found by the month it was distributed. This makes for an easy place to search for something. The link takes you to an external google docs folder for that month.

We also implemented using the same vendor for our jurisdiction wide listserv. This has worked as wonderfully. I do not have to monitor the account for spam, as the vendor does this for us. Proof of this had to do with email being sent having to do with the Coronavirus. Since I sent it to three different listservs, the vendor held the email until the researched that it was not spam. I was very impressed. It may have caused a slight delay (by a few hours) in everyone receiving it, but at least we knew they were doing what they were supposed to be doing. I am eternally thankful that this was implemented this year.

Due to the COVID-19 pandemic, we have not done the final audit of the Grand Guardian financials. CPA Karen Ciampaglio, PHQ, completed the Internal Revenue Service Form 990 and the Personal Property tax form of Maryland. The 990N for each Bethel was prepared by the Grand Secretary and filed with the IRS a month prior to the due date. All Maryland B-File information was filed no later than 10 days after the end of the month.

The proceedings were done and mailed to those who requested hard copies. We only had 6 people requesting an actual hard copy. The proceedings from 2018-2019 were posted to the website again this year. However, we had a terrible time with some executive members and committee chairs getting their final reports turned in. I had to email several times and some people I never received response one from my many emails. The proceedings are supposed to be done by December. We were not able to finalize the proceedings until March. If you look at the proceedings, you will that are several report missing (and this was not due to the event being canceled). This is unacceptable. I am asking that when future committee chairs are appointed, it is stressed to them the importance of getting their final reports done on time. The GS does not need the added stress of trying to track people down to get their reports. This job is essentially a second full-time job and no one should have to deal with what I dealt with this year.

We posted the directory online this year. This has worked out great. It cut the cost of printing directories down by quite a bit.

I need for it be known that many of the supplies used are donated by me, as I am able to utilize the use of some printing and paper as a donation from my office. We need to remember this in the future when a new Grand Secretary is elected.

The Grand Treasurer and I worked great together and we balanced the books without any issues each month. Thank you, Chris, for making my job a little easier.

Over the course of the term, we held several Council workshops. I was responsible for working with the secretaries on their duties and helping them to be better equipped to do their job. This was very well attended and well worth it. There were even some that were prior secretaries that learned something new. I was also tasked with working with the Bethels to update their Uniform Code. I provided them with them with templates, examples, etc. to make sure they were in line with the new format, as well as containing the appropriate wording. Many of our Bethel's Uniform Codes had not been updated since before the CAV requirement was put into place. This prompted us to remind the Uniform Code committee that they need to request a copy to review each year to make sure that the Bethel's Uniform Code is in compliance with the Supreme/GGC rules and regulations. In addition to my duties as Grand Secretary, I was Deputy for Bethel 16, Bethel Guardian at 42, Chaired Pageant and served on or helped several other committees.

To the Grand Guardian Council, again, thank you for having the faith in me to do this very time consuming and detailed job. It has been a year of challenges, changes and lots of research. However, I truly was honored to take on the challenge in making this transition as smooth as possible and assisting the many adults in the organization that made the GGC of DelMar possible. At the end of the day, it was a great year for the Daughters in both Maryland and Delaware, and that is what really matters.
